### President's Message

It is hard to believe but as we enter the dog days of summer it becomes painfully clear that summer will soon be over. I don't know about the rest of you but on these hot days, often annoyingly so, I tend to try to remember how it feels in January. That may sound a little Pollyannaish but I believe many people that live in the Pacific NW live for the nice weather we experience in the summer and early fall. I had the fortunate experience of having spent some nine years taking kids on habitat trips to Mississippi every summer. While I wouldn't trade that experience for anything I did note the contrast that exists concerning the weather. Hot, humid, suffocating experience with bugs and creepy crawler things. Try sitting outside at night and you would be swarmed by mosquitoes to the point of misery. It seemed as if everything that flies, crawls or slithers seems to want to bite you. Not to single out that state but much of the rest of the country also revels in such extremes. We on the other hand by contrast deal with very little of those irritants. Least I completely look like I have lost control of reality let me admit to the months of RAIN AND OVERCAST we experience for these few months' of pleasant weather.

Speaking of irritants let me address an issue that is coming up far too regularly from the board's perspective. In the past couple of months we have had to deal with conflicts between members that were potentially dangerous. There have been disputes between special use members that have ended up in arguments, one of which was particularly loud and inflammatory.

To the point that the club manager had to intercede between the two individuals involved. In another incident one of our range masters had to go to range one to deal with issues that were minor but inflamed into a verbal exchange that was totally avoidable. Let me put it as clearly as I can. The whole point of Special Use is to provide members with a "PRIVILEGE" of using any of the ranges unsupervised. This privilege requires that members are to adhere to safety protocol that is outlined very carefully in the special use classes. I only mention this as a reminder that we all have a responsibility to be vigilant and courteous in our dealing with fellow members. Without going any further let me conclude by asking a very simple question. Does anyone think it is a good idea to get into confrontation at a gun range? I will leave it at that but note that privileges are granted and can easily be taken away.

Please read the various activity chairs reports to get a good idea of what is happening at our club on any given day. It is also important to check the calendar before you plan to come to the range. There may be an activity that is going on that will prevent you from using the range when you have planned. This is particularly important if you are traveling long distances or putting a party of friends together to use the range. I think it is particularly notable to praise the archery committee for the yeoman work they have done on the walk through range. I have heard nothing but praise as to how it is set up. In addition, you will note that range four adjacent to the chalet is getting set up as a multiuse range



archery, pellet gun and other uses. It will in all probability be finished sometime during the early fall.

I want to point out that we have been notified that there is potential money available for a grant through the NRA foundation. If we have a member that is well versed in the process of grant writing we would so much want to hear from you? The grand plan is to build a multipurpose pistol and light rifle range that can be

#### JULY 2024 BENCHREST CENTERFIRE TACKDRIVER MATCH REPORT

The TackDriver Match consists of shooting both a Group and Score target at 300 yards using the IBS 200 Yard VFS Target for score and IBS/NBRSA 300 Yard Group Target for group.

There were seventeen contestants in this month's match with ten contestants in Expert division and seven in the Sharpshooter Division.

Match 1 Expert Division: Score: Jeff Lewis finished first with a score of 51. Jeff Locke was second with a score of 50. Bruce Teel, Rick Beginski, Pat Farrell, and Larry Wright tied for third with scores of 49. Group: Richard Nicol was first with a score of .303. Jeff Lewis placed second with a score .843 and Bryan Zolnikov was third with a score of .943.

Match 1 Sharpshooter Division: Score: John Lowdon was first with scores of 47.Kevin Turner and Tim Turner tied for second with scores of 43. Group: Bill Rice was first with a score of 1.320. Kevin Turner was second with a score of 1.340 and John Lowdon placing third with a score of 1.549

There was a three way tie for first place between Jeff Lewis, Jeff Locke, and Bryan Zolnikov who tied with four points for their rankings in the score and group targets categories. The tie breaker was determined by the total average of the aggregate group scores. Jeff Lewis's score was .8450 and he was awarded the 2024 TackDriver Trophy. Jeff Locke was second with a 1.0613 and Bryan Zolnikov was third at 1.0618.

The combined score and group aggregate winner of the Sharpshooter Division was Bill Rice with a total rank score of 2 points by ranking first in score and first in group score. Tim Turner and Kevin Turner tied for second with a total rank score of 5. Kevin Turner won the tie breaker with an aggregate group scores of 1.7138 ahead of Tim Turner's score of 1.8373.

#### JUNE 2024 RIMFIRE 100/200 YARD MATCH

This report didn't make it into the last newsletter, so here it is now.

The June 100 / 200 Yard Rimfire Match was held on Saturday June 29th. There were 11 Competitors at the Match with 10 shooting off a Bench and 1 shooting as "fully supported" prone. We welcomed 5 first time Competitors at the Match this Month: Peter Jaszczak, Dale Hacker, David de Jung, Jason Pahlman, and Garrett Williams. David had the shot of Century and was the Buck-A-Shot winner this month. It was a really nice day for a June Match as the temperature was in the mid to upper 60's with clear skies. The wind speeds were in the 0 - 2 mph range so the wind flags were hardly moving and there were occasional gusts that peaked in the 2 - 4 mph range. The challenge was the wind direction started the day coming from the NNE / NE during the 100 yard target and the first 7 minutes of the 200 yard target. But in the next 10 minutes it switched to a SE directions which gave a little boost to the 22LR rounds at 200 yards which impacted on where they landed on the target.

#### 100 Yards Results:

Keith Wilson started the Match off shooting a perfect 100 yard target for 200 points. This tied him with TQ and Mark Huber for the record top score on the 100 yard target for the 100 / 200 yard Match. The 10 ring on the CBA target is only 0.69 inches in diameter, which means a very tight grouping is required for a 22LR at 100 yards. Three Competitors: Alex Powell, TQ and Eric Carter who was shooting prone, tied for 2nd place. All 3 of them shot an outstanding score of 197 out of 200. For the June Match, 7 of the 11 Competitors shot a 195 score or better at 100 yards which is outstanding.

#### 200 Yards Results:

Keith Wilson had the top 200 yard score of the Match shooting a 190 out of 200 and took 1st place. This was Keith's third 190 score at 200 yards and ties him for 5th place on the Match record scores at 200 yards. Keith was on pace for setting a new record score for the 200 yard target after dropped only 3 "very close" points on the first bull worth 100 points. But as the wind direction changed during his second bull, he dropped 7 points. This just goes to prove at 200 yards 22LR rounds are easily impacted by the wind. Mark Huber shot an outstanding 188 and was only 2 points back of Keith for 2nd place. David de Jung was only 1 point behind Mark for 3rd place shooting a 187.

#### Guest topics:

He is with 4H and their group operates out of the fairgrounds. Because they are on the fairgrounds, the only discipline they can practice at their facility is archery. He came to the board meeting to find out if we would be willing to have them use our facility to practice longer range archery, rifle and shotgun. Joe R. said we have several programs they could plug into. Joe R. suggested Trevor connect with Gabe, Martin and Dave to discuss.

Jason came to share an unpleasant experience he had at the range. He was very kind in his presentation of the situation. His intent was to help our club be better and continue to be a great place to bring family and friends. We discussed his experience and what we can all do to keep our club a great place.

#### Committee reports:

Notes from the committee reports that were presented during the board meeting are below.

#### Archery report:

The following content was provided by Gabe Shank and was shared ahead of the board meeting. July is a busy month for archery tournaments and fun shoots.

WCW is holding the WSAA State Field Championship on July 13 and 14th. We will have a few participants camping in the back by shotgun over the weekend. The FITA Field and Upper Flat range will be open to members.

WCW will be holding the Big Game 3D Archery shoot on the weekend of July 20 and 21st. The back course behind shotgun is not scheduled to be used this year, but if shotgun wants the weekend off, we can open the back course. I'll leave this for board discussion.

WCW will also be holding the WSAA State Target Championships on August 3 and 4th. The FITA Field will be closed that weekend for the tournament.

The archery committee has been in discussion for new target butts on the flat range. Jim Thompson bought the last batch sometime in 2019-2020. The company he bought them from is not making them anymore. We will need to figure out the most cost effective targets for the upper flat range. Aaron can talk a little more on this subject.

#### Handgun Report:

The following content was provided by Dave Rusko and was shared ahead of the board meeting.

Steel targets have been moved to Zone 1 (Shooting lanes 1-4). Signage has been updated.

22 members obtained Pistol Special Use in June 2024.

We had 10 new members attend the June 11, 2024 New Members Orientation (NMO).

We had 6 new members attend the June 15, 2024 NMO.

July 2024 NMO is scheduled for 16-July and 21-July.

The clubhouse west door header repair has been completed. Thank you to Nick Galash for the donation of his time and labor. Range 2 50-Yard target frame fortification

has been completed.

All NRA Shotgun courses (First Steps and Basic) will be held in the Shotgun clubhouse moving forward.

#### **Rifle Report:**

The following content was provided by Martin Morehouse and was shared ahead of the board meeting.

Martin is going to put together a Garand class and a Rifle Fundamentals class. The minimum charge for our facility is currently 4 hours. Martin asked if we should decrease this to 1 hour. Robert said the four-hour minimum is for shotgun. The board agreed we could change the minimum rental for other ranges and facilities is one hour.

Martin asked if we should have a central repository for our passwords for all our accounts. Dale suggested we just add additional people to the accounts instead of multiple people knowing the same passwords. Dave L. asked if we should keep a paper copy. Dale recommended we do not keep a paper copy of passwords. Martin discussed scheduling time for members on Range 1. There is a lot of open time on Range 1 on most weekends. So, we will not be making any adjustments at this time.

There was a concern about us losing money for our matches. Martin said we charge similar but a little less than other ranges. Joe R. said we can raise rates because of our location.

Martin and Dave decided we would allow people to bring in their own wood for target frames and they have been given a specific location to store their wood.

Rifle matches for the coming month are Rimfire Benchrest on 6 July, ARA Rimfire on 13 July, NRA Highpower on the 14th, and Centerfire Benchrest match on 20 July. Our next NRA Basic Rifle Class is on 22 – 23 June 2024.

Indoor smallbore practice is on the calendar on Tuesdays from 6 to 9 PM. See me for more information.

Our next NRA Highpower match will be on 14 July. It is open to any military style rifle from Krag Jorgenson to Mauser to the latest M4 clones. The shooting is from the standing, sitting and prone positions, with two rapid-fire stages and two slow-fire stages. You are welcome to visit and see how it works. The club even has M-1 Garands for members to use for this match, if you want to coordinate with us to check one out.

Special Use Process: 15 members attended the rifle special use class in June. The July Rifle Special Use range session is on the 28th.

Project Appleseed adjusted their event in November to work around the existing benchrest match on Range I. They will run the first part of their event, mostly registration and lecture, in the clubhouse, then move to the range after the benchrest match. Civil Air Patrol plans a rifle event in the clubhouse on 13 July. We have smallbore practice times in the clubhouse on Tuesdays and Fridays, and on the weekends, except for any conflicts with other events. If anyone needs supplies for an activity, other than normal maintenance materials, they should work through the rifle committee. An example would be something used only in an event or match. These things should be budgeted into the event, not paid out of club funds.

Do we have members who are not signing in and out of ranges? Do we need more oversight of this?

#### Shotgun Report:

The 7 week long spring shotgun league has completed. Jeff Dornes will be tabulating and sharing results and prizes. As of week 6 - participants had shot 288 rounds.

Phil Kiner visited WCW in early June and held a 1-day, and a 2-day clinic. 20 shooters were able to participate. Feedback was overall very positive. Phil was a great instructor and packed a lot into 10+ hour days of teaching. He also had very positive feedback about the club itself - which is really gratifying given he's taught in many US states.
