# CLASSES, WE HAVE CLASSES

Do you know someone who is looking for basic firearms training? We have NRA certified classes here almost every weekend.

These classes are designed to introduce newcomers to shooting in a safe and welcoming atmosphere.

When the weather is warmer, we have our First Steps Shotgun class on the first Saturday of the month. This is an introduction to shotgun use and basic trap shooting

Basic Pistol is scheduled on the second weekend of each month. Our students learn the fundamentals of both revolvers and semiautomatic pistols.

Home Firearms Safety class is held on the third Saturday of each month. This class is a nonshooting class, covering safe handling of all types of firearms.

Basic Rifle is set for the fourth weekend of the month, using bolt-action rifles. We cover the basics, as well as a bit of position shooting.

Our instructors have recently started offering Metallic Cartridge Reloading classes, usually on the third Sunday of the month.

# PROJECT APPLESEED REPORT

Here's a report on the last Appleseed event of the year, on 16 November, from the Appleseed Shoot Boss, Ian Borchert.

What an event! Fourteen very eager shooters joined us for our final two-day event at the WCW Shoot Sports range, some shooters new, others returning with more friends. Faced with an early sunset and reduced shooting light, this group was incredibly efficient and clearly wanted to send as many rounds as possible downrange. They wasted no time in putting up impressive sighter groups while enduring the chill of the weekend. Not quite Winterseed conditions but getting close. We don't often complete an AQT on Saturday with time to spare but this group listened well and absorbed instruction like a sponge to make it happen! Mark W was our first Rifleman of the event with a score of 210 on Saturday and he proved again on Sunday this was not a fluke with re-qualifying scores of 217 and 221.

On Sunday review went by quickly, none of this was new to these shooters at this point. They were ready for more drills, AQTs, and moving with such a purpose I was starting to think we'd run out of the planned drills and would have to come up with new ones on the fly! Isabella scored 222, Josh 240, Michael J 216, Ben H 215, Chris 226, and Joe finished with a 211 on the last AQT of the weekend after previous attempts had gotten him as close as 208. For all these shooters it was their first time achieving Rifleman. Everyone else was incredibly close, multiple shooters in the 200+ range but not quite able to reach the Rifleman qualification before daylight told us it was time to wrap up. With consistent dryfire, fine-tuning of the steady hold factors, practice maintaining a comfortable and stable position, and acquiring NPOA quickly, I have no doubts every shooter who was at this event will earn themselves a path. Thank you for an excellent finish to 2024 and excited to see you back in 2025!

#### **Guest topics:**

Bill Miele presented.

Bill wanted to make sure we use the same document in all locations. He also wanted to make sure we follow document control. We discussed making sure it is clear when we make changes and know which document is correct. Dale suggested putting the revision in the filename. He also suggested putting the name of the document in the footer. Dave R. brought up that we do not deal with ages 21 through 26 in the new bylaws. Dave L. and Bill M. suggested we include that type of information in our policy book instead of the by-laws. We discussed how the committees would work. Non-directors can be in committees. We will need to recruit people to participate in our committees. Scott asked if there is a chart that shows how many committees there will be and how many people need to have on each committee. The information is in the by-laws. So, one can be drawn up. Ian Borchert presented.

He came as a representative of Project Appleseed. He came to ask if anyone had any questions about Project Appleseed. He briefly shared a little about the program. There are some events they would like to put on the calendar and have been working with Martin. Martin said there are no calendar conflicts.

#### Archery report:

# Handgun Report:

The following content was provided by Dave Rusko and was shared outside the board meeting.

Bullseye Pistol league has requested relocation of the steel targets on the pistol range. They have concerns about damage to the turning target mechanism. Researching additional protections or alternative locations.

Failed air compressor repair on Range 3 in progress. Will be repaired after the Bulls-Eye league moves into the Clubhouse for the winter. Temporary compressor in place and continues to service Range 3 reliably. Air pistol shooters with fixed air tanks have been observed performing refilling off the firing line and in violation of the no firearms handling behind the firing line policy. A temporary electrical connection to permit refilling on the firing line has been put in place. A permanent electrical solution to be planned. The Pistol Rules policy has been updated and signage is being created. Steve Read will be assuming the position of Event coordinator for the Bullseye Pistol league program.

No members obtained Pistol Special Use in October 2024.

We had 14 new members attend the October 2024 New Member Orientation (NMO) classes.

November 2024 NMO scheduled 1-November and 16-November.

## **Rifle Report:**

The following content was provided by Martin Morehouse and was shared outside of the board meeting.

A member asked if we could have a lower cost membership for out of state members. Martin will collect more information to share with the board.

Martin shared an update on all the discipline problems from last month. He talked to all the members involved and they all were receptive to our feedback and apologized. No further action will be taken. Rifle matches for the coming month are Rimfire Benchrest on 2 November, NRA Highpower on 3 November, ARA Rimfire on 9 November, and Centerfire Benchrest match on 16 November. The Junior Rifle group will also have IERPA postal matches on 3, 10, and 17 November.

Our next NRA Basic Rifle Class is on 23 – 24 November 2024.

Indoor smallbore practice is on the calendar on Tuesdays from 6 to 9 PM. See me for more information.

There were three members in attendance at the last committee meeting.

Ten members attended the rifle special use classes in October. The November Rifle Special Use range session is on the 24th. Project Appleseed has proposed their planned events for 2025. They don't appear to conflict with any of our regular scheduled matches or classes.

We replaced firing pin springs on six of our Savage Mark II NRA class rifles, and it looks like they are working better. We will also be storing them uncocked, to reduce compression fatigue in the springs. We are looking into improved mounting methods for our steel targets on Range 1, as well as additional targets. Plan to try a series of smaller targets and several mounting methods to see if they work better than the existing rubber straps. This will be about \$200 to add about ten more targets to the range.

We need to set a date in April or May for lead reclamation and bullet trap maintenance in the clubhouse. Need to plan on using some air chisels to break up the lead for removal, as we had to use hand chisels before. The lead tends to compact over time.

## Shotgun Report:

The following content was provided by Fred Harmon and was shared outside of the board meeting.

We had a short meeting with 3 members present. There were a few things brought up. We should put updated placards placed in the clubhouse that specify the exact information and format for calling EMS in the event of an incident. This should include the address, and the specific information to be relayed to the 911 operator to insure expedient response. We may wish to consider moving the defibrillator to the clubhouse area, as there is always a possibility that an incident may occur during a Members Night, when the office area, where it is currently located, is locked. After discussing this, it was suggested that we discuss with the board, moving the AED to a location similar to the rifle range.

We should establish a group of members who are regulars at Members Night who have a list of contacts if an incident occurs and make an emergency packet that has forms and contact info if an incident occurs. Kind of a "in case of emergency, break glass" type kit.

Otherwise, things are going well. We have had some talk about some 5-Stand Fundamentals. I have talked with Gary, who is excited about it, and suggested some instructors. Tim Lave talked with us, and he would consider instructing after the first of the year, as he has other commitments at this time. Setting up a scheduled time for Doubles practice has gotten some interest. This would allow people to practice for the Multiplexes, as we can do 16yd and Handicap without any changes to the traps and would give others a chance to give Doubles a try and find they enjoy it. I discussed the idea with Dave Rusko of creating a webpage or video that explains the shotgun range and its offerings. We could show the rules, New Shooter Orientation for first time users, the 16vd Trap, Continental, Doubles and our Fundamentals class offerings. If we can produce a good format, we could look at using it as a "best practice" and consider making similar ones for our other programs. If we can get people excited and know what to expect, we could attract more shooters. We should focus on the diversity of age, sex and cultures who are welcomed into the club and the comradery of the members, which makes it a social group, and more than just a place to shoot.

## Manager's Report:

Robert Haverstock presented. Dave Carter from white flyer called and there is a sale on clays. The deal was so good, Robert purchased 6 pallets. He ordered earlier than our original plan because of the savings. Robert will be figuring out where to store them. Having problems with heaters in the clubhouse. Robert had the heaters serviced. The starter is going bad on one. He would like to replace the starter in both. He will get an estimate this week. They completed the employee reviews and

plans for wages. Robert is getting a lot of texts and calls early

in the morning. Robert asked that people do not call him until after 8am.

Two rentals of our club have been requested. One is shotgun and that one is okay. The other renter wants to do rifle and pistol. They want to draw from holster and want to shoot standing up. They don't have insurance. Robert said we should not rent to the second group. The board agreed. Joe mentioned we have some maintenance problems. Our employees don't have the experience and knowledge to handle the maintenance themselves. Joe believes we need to find a maintenance supervisor.

## Treasurer's Report:

Joe Maggiora presented.

They finalized the budgeting for employees. WaFed promo board is up. They will keep it up through November.

Range income down but sales are up. Net revenue is slightly better than this time last year

#### **Trustees Report:**

John Sutton presented.

Dave L. said Carson got the Bobcat running again. So, we don't need to purchase a new one.

Scott said the shotguns we have for training are not suitable for the sport. They are not good for Continental and 5 stand. We need to get the correct over and under shotguns for youth. We should purchase three average guns and two smaller ones. We discussed it. John S. said he would be happy to head up finding these. Joe suggested we ask the membership if they have any they would be willing to donate. John S. will send Martin information on what to send membership in an email asking for shotguns. Old Business:

Asphalt patching of driveway completed. Range 4 containment wall materials received. Construction to proceed as time and availability permits.

Dave R. reported on the decking in front of the office. Planet Builders LLC provided a quote. They said it will cost \$35,000+tax. It will have steel railing and Trex decking. They will change the steps into ramps. It will be a 3-week project after the permit is approved. No safe way to keep the office open during the construction. Dave R. suggested we rent a small rental unit to run the office out of. Dave R. said he did not have them give us an estimate for the small roof next to the office. Dave L. suggested we have them bid that too and we just have them do it all. Dave R. will investigate it. They can start 2 weeks from signing the contract. We will pay at the end of the job. Dave L. moved we approve this. Martin M. seconded. Passed.

#### New Business:

Chalet parking widening is completed. Dave R. asked if we allow public shooters to train other public shooters on our ranges and charge the student a fee WITHOUT the trainer having a signed agreement with the range? The board said no.

Dave R. asked if we would be collecting food for the domestic violence organization we support. Joe said we should. Joe said we usually give them a donation too. Dave R. will reach out to them to coordinate. Nextdoor app has a WCW Inc. page on it. Dave R. asked if we should shut it down. The board said yes. Dave R. will work with Martin to shut it down.

Richard Ripley has a lot of responsibilities outside of WCW training, so he is going to stop running our training programs. Dave R. and Martin will work as co-chairs for our training. # New Business:

Joe Rinaldi asked how many members read the new bylaws. He said the purpose of this meeting is to get their thoughts on what we have done with the bylaws and get your approval to move forward.
